

2024 Waterfowl Hunters' Expo Waterfowl Sporting Clays Event

Cost of event participation is \$10, payable the day of event - Saturday, August 24, 2024 at Sunnyview Expo Grounds. Event will start at 9:00AM and finish about 1:00PM. The first 120 teens, age 14 thru 18 will be accepted and then sign up will be closed. Each participant is required to have completed a certified hunter ed. course and practice safe firearm handling and use at all times during the event. The event consists of 10 targets per participant and will include 2 targets per call, of unknown origin. 5 participants will shoot per round with no movement of stations. Participants will bring their own **12 gauge** shotgun capable of shooting two consecutive rounds without reload. Only **12 gauge** shotguns will be allowed at this event. Firearms will be inspected prior to shooting, at a staging table. No ammunition is allowed outside those shells supplied at the event. Firearms must be cased at all times except when actively involved during shooting at the event. Prizes will be given out at the end of the event. Each participant will be given a ticket for each target struck during the event. The tickets will be entered for a drawing of 4 prizes including one Stoeger 3020 camo shotgun and a 4-person guided hunt.

To receive a notification of each participant's shooting time you will need to send a confirmation email to Reed Kabelowsky r.kabelowsky@sbcglobal.net or Scott McFaren smcfarren@ducks.org. The notification will be sent to the e-mail provided on the sign up tab, about a week before the event.

Reasonable accommodations and assistance will be provided for handicap participants. Each participants will bring eye protection, hearing protection, 12 gauge shotgun capable of firing 2 consecutive shells, case for firearm, \$10 fee, consent form, and a safe, competitive, courteous attitude. This event is put on by shooting sports volunteers who support youth shooting sports and youth conservation activities and will be treated with courtesy and respect at all times.
